PREFACE

This report is issued on a monthly basis and aims at providing a general view of the external trade of Cyprus and its partner countries for August 2020. It is divided into three parts. Part A pertains to total trade statistics under the general trade system, part B to extra-EU trade statistics under the special trade system and part C to intra-EU trade statistics. All values shown in the tables of this report are in euros.

The statistics of trade with non-EU countries (extra-EU trade) are compiled mainly from 'THESEAS' system, the computerized system of customs authorities for imports and the customs computerized system for exports. The statistics of trade with EU countries (intra-EU trade) are compiled mainly via the Intrastat system and the data collected via the VAT returns.

This report was prepared by Mrs. Ioanna Leontiou, Statistics Officer, under the guidance of Mr. Sofronis Vikis, Statistics Officer A' and the general supervision of Mr. Pantelis Protopapas, Head of the Business, Energy, Environment, Agriculture, Science and Technology and Foreign Trade Statistics Division.

INTRODUCTION

DEVELOPMENTS IN EXTERNAL TRADE FOR AUGUST 2020

Total imports (covering total imports from third countries and arrivals from EU countries) in January - August 2020 amounted to €4.828,8 mn as compared to €5.438,4 mn in January - August 2019.

Total exports (covering total exports to third countries and dispatches to EU Member States) in January - August 2020 were €1.953,7 mn compared to €2.190,2 mn in January - August 2019. As a result of the above developments the trade deficit was €2.875,1 mn in January - August 2020 compared to €3.248,2 mn in the corresponding period of 2019.

Total imports in January - August 2020 include the transfer of economic ownership of mobile transport equipment (vessels), with total value of €712,1 mn as compared to €786,3 mn in January - August 2019. Total exports in January - August 2020 include the transfer of economic ownership of mobile transport equipment (vessels), with total value of €642,4 mn as compared to €749,3 mn in January - August 2019.

Total imports

Imported goods were €498,7 mn in August 2020 and €611,2 mn in August 2019.

a. Total imports by HS section

For August 2020 section XVII ‘Vehicles, aircraft, vessels and associated transport equipment’ lead the list with €86,6 mn followed by section V ‘Mineral products’ with €79,4 mn, section XVI ‘Machinery and mechanical appliances, electrical equipment and parts’ with €70,0 mn, section VI ‘Products of the chemical or allied industries’ with €51,3 mn, section IV ‘Prepared foodstuffs, beverages, spirits and vinegar, tobacco and manufactured tobacco substitutes’ with €50,9 mn, section XI ‘Textiles and textile articles’ with €21,8 mn, section VII ‘Plastics and articles thereof; rubber and articles’ with €20,7 mn, section XV ‘Base metal and articles of base metal’ with €20,0 mn and sections XX ‘Miscellaneous manufactured articles’ and II ‘Vegetable products’ with €15,9 mn.

b. Total imports by economic destination

- Consumer goods valued at €162,1 mn or 32,5% in August 2020 and €174,4 mn or 28,5 % in the respective month of 2019.
- Intermediate inputs valued at €125,6 mn or 25,2% in August 2020 as against €110,8 mn or 18,1% in August 2019. The manufacturing sector absorbed €77,8 mn in August 2020 as compared with €66,2 mn in August 2019. Raw materials for the construction sector were €19,9 mn in August 2020 and €16,7 mn in August 2019.
- Transport equipment with their parts accounted for €97,1 mn in August 2020 as compared with €156,8 mn in August 2019. Ships, boats and floating structures valued at €30,5 mn in August 2020 as compared with €82,6 mn in August 2019. Passenger motor vehicles were €45,1 mn in August 2020 and €43,0 mn in August 2019.
- Fuels and lubricants, including crude petroleum oil, valued at €70,4 mn in August 2020 and €127,4 mn in the corresponding month of 2019.
- Capital goods valued at €39,6 mn in August 2020 and €35,2 mn in August 2019. The manufacturing sector was €7,3 mn in August 2020 as against €7,5 mn in August 2019. Capital goods for the construction and mining sectors valued at €4,7 mn in August 2020 and €3,2 mn in August 2019. The transport, storage and communication sector valued at €7,7 mn in August 2020 and €6,0 mn in August 2019. Capital goods for agriculture accounted for €1,3 mn in August 2020 and €1,6 mn in the corresponding month of 2019.

c. Total imports by area

- The European Union (excl. intra EU unspecified countries) continued to be the main source of supply of goods to Cyprus in August 2020 with a share of €333,2 mn of total imports. Major suppliers within the Union were Greece with €123,1 mn, Italy with €47,5 mn, Germany with €35,1 mn, the Netherlands with €22,7 mn, Spain with €20,0 mn, Belgium with €17,6 mn, Denmark with €15,4 mn, France with €9,3 mn, Romania with €8,1 mn and Bulgaria with €7,1 mn. (United Kingdom is now excluded from EU countries)
- Imports from all other European countries totaled €59,3 mn in August 2020. Major suppliers were the United Kingdom with €47,1 mn, Switzerland with €4,0 mn and Turkey with €2,9 mn.
- Imports from the rest of the world in August 2020 amounted to €106,3 mn. Major partner countries were China with €28,6 mn, Israel with €18,9 mn, Marshall Islands with €11,4 mn, India with €6,4 mn, the United States with €3,9 mn, Japan with €3,3 mn, Viet-Nam with €2,9 mn, Cuba with €2,5 mn and South Korea with €2,2 mn.

d. Total imports destined for home use

Imported goods destined for home use were €447,4 mn in August 2020 and €535,2 mn in August 2019.

Imports destined for home use by economic destination

- Consumer goods valued at €153,2 mn or 34,2% and €162,5 mn or 30,4% in August 2020 and August 2019, accordingly.
- Intermediate inputs valued at €123,8 mn or 27,7% in August 2020 as against €109,7 mn or 20,5% in August 2019. The manufacturing sector absorbed €76,5 mn in August 2020 and €65,4 mn in August 2019.
- Transport equipment with their parts accounted for €94,6 mn in August 2020 as compared with €148,9 mn in August 2019. Ships, boats and floating structures valued at €30,5 mn in August 2020 as compared with €82,6 mn in August 2019. Passenger motor vehicles were €45,7 mn in August 2019 and €41,1 mn in August 2019.
- Fuels and lubricants, including crude petroleum oil, valued at €34,3 mn in August 2020 and €73,1 mn in the corresponding month of 2019.
- Capital goods valued at €37,6 mn in August 2020 and €34,3 mn in August 2019. The manufacturing sector was €7,1 mn in August 2020 as against €7,4 mn in August 2019. Capital goods for the construction and mining sectors valued at €4,5 mn in August 2020 and €3,2 mn in August 2019. The transport, storage and communication sector absorbed €6,8 mn in August 2020 as against €5,6 mn in August 2019. Capital goods for agriculture accounted for €1,3 mn in August 2020 and €1,6 mn the respective month of 2019.

Total exports

Total exports, including stores and provisions, accounted for €197,4 mn in August 2020 as compared with €230,6 mn in August 2019.

a. Total exports, including stores and provisions, by HS section

For August 2020 section V ‘Mineral products’ lead the list with €64,2 mn, followed by section XVII ‘Vehicles, aircraft, vessels and associated transport equipment’ with €44,9 mn, section I ‘Live animals, animal products’ with €25,7 mn, section VI ‘Products of the chemical or allied industries’ with €23,7 mn, section XVI ‘Machinery electrical equipment and parts’ with €10,3 mn, section IV ‘Prepared foodstuffs, beverages, spirits and vinegar, tobacco and manufactured tobacco substitutes’ with €6,6 mn, section XVIII ‘Optical, photographic, cinematographic, measuring, checking, precision, medical or surgical instruments, clocks and watches, musical instruments, parts and accessories thereof’ with €4,4 mn, section XV ‘Base metal and articles of base metal’ with €2,7 mn, section II ‘Vegetable Products’ with €2,0 mn and section VII ‘Plastics and articles thereof’ with €1,4 mn.

b. Total exports of domestically produced goods, excluding stores and provisions, by category

- Industrial products of domestic produce exported during August 2020 valued at €96,6 mn or 95,0% and €78,1 mn or 93,0% in August 2019.
- Exports of raw agricultural products valued at €3,7 mn or 3,6% in August 2020 and €4,6 mn or 5,5% in the corresponding month of 2019.
- Mineral exports valued at €0,4 mn or 0,4% in August 2020 and €0,3 mn or 0,4% in August 2019.

c. Total exports by area

- Exports to the European Union (excl. intra EU unspecified countries) accounted for €51,4 mn in August 2020. Exports to Greece accounted for €23,3 mn, to Sweden for €3,6 mn, to France for €2,9 mn, to Germany for €2,3 mn, to the Netherlands for €2,1 mn, to Malta for €1,8 mn, to Bulgaria, Czech Republic and Denmark for €1,6 mn and to Italy for €1,5 mn.
- Exports to north Africa accounted for €27,5 mn in August 2020, to Near and Middle Eastern countries for €27,1 mn, to other Asian countries with €23,3 mn, to other European countries for €22,2 mn, to other countries of Oceania and Polar regions for €12,5 mn, to other African countries for €5,5 mn, to central America and Caribbean with €4,5 mn and to north America with €3,8 mn.
- Stores and provisions to ships and aircrafts in August 2020 valued at €12,6 mn, exports to high seas in August 2020 valued at €0,2 mn and exports to countries and territories not specified in August 2020 amounted to €4,0 mn.

APPENDIX

DEFINITIONS OF TERMS USED

Arrivals

"Arrivals" are analogous to imports.

Arrivals include:

- a) Goods in free circulation which enter the statistical territory of Cyprus.
- b) Goods which have been placed under the customs procedure for inward processing or processing under customs control (for processing, transformation) in another Member State and which enter the statistical territory of Cyprus.
- c) Certain goods are included in statistics based on specific conditions e.g. aircrafts and ships whose economic ownership has been transferred from a natural person or legal entity established in another Member State to a natural person or legal entity established in Cyprus are included in the statistics of arrivals of Cyprus.

Dispatches

"Dispatches" are analogous to exports.

Dispatches include:

- a) Goods in free circulation which leave the statistical territory of Cyprus bound for another Member State.
- b) Goods which have been placed under the customs procedure for inward processing or processing under customs control (for processing, transformation) in Cyprus and which are destined for another Member State.
- c) Certain goods are included in statistics based on specific conditions. In particular, aircraft and ships whose economic ownership has been transferred from a natural person or legal entity established in the Cyprus to a natural person or legal entity established in another Member State are included in the statistics of dispatches of Cyprus.

Imports

Imports under special trade system include:

- a) Goods, which enter the statistical territory of Cyprus from a non-Member State country and are:
 - Placed under the customs procedure for release into free circulation (goods intended to be consumed in Cyprus or dispatched to another Member State), either immediately or after a period in a customs warehouse; or
 - Placed under the customs procedure for inward processing or processing under customs control (usually goods destined to be processed, transformed for subsequent re-export) either immediately or after a period in a customs warehouse,
- b) Certain goods are included in statistics based on specific conditions e.g. aircrafts and ships whose economic ownership has been transferred from a natural or legal person established in a non - Member State country to a natural person or legal entity established in Cyprus are included in import statistics of Cyprus.

Exports

Exports under special trade system include:

- a) Goods that leave the statistical territory of Cyprus bound for a non-Member State country, having gone through:
 - The customs export procedure (final export, export following inward processing, etc.); or
 - The customs outward-processing procedure (usually goods destined to be processed, transformed for subsequent re-import).

- b) Certain goods are included in statistics based on specific conditions e.g. aircrafts and ships whose economic ownership has been transferred from a natural or legal person established in Cyprus to a natural person or legal entity established in a non - Member State country are included in export statistics of Cyprus.

The harmonised commodity description (HS) and partner country coding system

The Harmonised System is a legal instrument adopted by the Customs Co-operation Council (now the World Customs Organization) in June 1983 and the International Convention on the Harmonised System (HS Convention) entered into force on the 1st January 1988.

According to the HS Convention, the HS means the nomenclature comprising the headings and the subheadings and their related numerical codes, the section, chapter and subheadings notes and the general rules for the interpretation of the Harmonised System. The HS designed as a multipurpose nomenclature, to be used for transportable goods.

Both HS and CN are therefore concerned heavily with the nature or material of the product.

The structure of the HS and the CN classifications (for the year 2020) is illustrated in the following table:

Country classification

The classification of countries is the country nomenclature (Geonomenclature) as set out in the Commission Regulation (EU) No 1106/2012. The full list of countries is given in an essentially geographical order in Table 4, Part A, total trade statistics.

For exports and dispatches, the trading partner is the non - EU country (or Member State) of final destination of the goods. The last country to which the goods are specifically directed on their outward movement from Cyprus is regarded as their final destination. This is not necessarily the country in which the good will be unshipped or that in which they will be finally consumed.

For imports (extra-EU trade), the trading partner is the country of origin. In general, goods obtained entirely from a given country originate in that country. A product in the production of which two or more countries were concerned, is considered as originating in the country in which the last transformation or substantial processing took place. Packing, repacking and sorting are not regarded as manufacturing processes.

For arrivals (intra-EU trade), the trading partner is the Member State of consignment of the goods.

Trade systems

There are broadly two approaches, closely linked with customs procedures, used for the measurement of international trade in goods: the general trade system and the special trade system.

General trade system

The general trade system is the wider concept and under it the recorded aggregates include goods entering or leaving the economic territory of Cyprus with the exception of simple transit trade or transshipment of goods. Quasi transit trade is included in general imports and exports statistics. In particular, goods which are received into customs warehouses are recorded as imports at that stage whether or not they subsequently go into free circulation in Cyprus. Similarly, outgoing goods from customs warehouses are included in the general trade aggregates at the time they leave Cyprus.

Special trade system

The special trade system is a narrower concept. Goods from a non - EU country which are received into customs warehouses are not recorded in the special trade aggregates unless they subsequently go into free circulation in Cyprus (or are placed under the customs procedures for inward processing).

Similarly, outgoing goods from customs warehouses are not recorded as exports.

Stores and provisions

Stores and provisions denote ships and aircrafts stores and supplies.

Ships and aircrafts stores mean the various products for consumption by the crew and passengers of vessels or aircrafts;

Ships and aircrafts supplies means the products for the operation of the engines, machines and other equipment on vessels or aircrafts, such as fuel, oil and lubricants.

Domestic and foreign goods

Domestic goods are goods originating in the economic territory of Cyprus; if they have been wholly obtained in it or were substantially transformed by processing in it, so that the processing confers domestic origin. Goods originally imported and having undergone only repair or minor operations, which leave them essentially unchanged are not defined as domestic. Minor operations include packaging, bottling, cleaning, sorting etc.

Foreign goods are goods originating in the rest of the world, i.e. not included in the economic territory of Cyprus and compensating goods obtained under the outward processing procedure when such processing confers foreign origin.

Data and electronic publications (pdf) are available on the website free of charge. Paper publications are obtainable from the central offices of the Statistical Service in Lefkosia and from the Printing Office of the Republic of Cyprus.

European Statistical Data Support (ESDS)

All the information contained on the website of Eurostat (<http://ec.europa.eu/eurostat>) is available free of charge to all users. Amongst other, the website offers access to statistical data contained in Eurostat's databases as well as to the publications of Eurostat in electronic format (pdf).
