PREFACE

This report is issued on a monthly basis and aims at providing a general view of the external trade of Cyprus and its partner countries for December 2019. It is divided into three parts. Part A pertains to total trade statistics under the general trade system, Part B to Extra-EU trade statistics under the special trade system and Part C to Intra-EU trade statistics. All values shown in the tables of this report are in Euros.

The statistics of trade with non-EU countries (Extra-EU trade) are compiled mainly from 'THESEAS' system, the computerized system of Customs Authorities for imports and the customs computerized system for exports. The statistics of trade with EU countries (Intra-EU trade) are compiled mainly via the Intrastat system and the data collected via the VAT returns.

This report was prepared by Mrs. E. Toumbaki, Assistant Clerical Officer, under the guidance of Mr. S. Vikis, Statistics Officer A'.

INTRODUCTION

DEVELOPMENTS IN EXTERNAL TRADE FOR DECEMBER 2019

Total imports (covering total imports from third countries and arrivals from E.U. countries) in January-December 2019 amounted to €8.235,9 mn as compared to €9.200,0 mn in January-December 2018.

Total exports (covering total exports to third countries and dispatches to E.U. Member States) in January-December 2019 were €3.146,2 mn compared to €4.309,9 mn in January-December 2018. As a result of the above developments the trade deficit was €5.089,7 mn in January-December 2019 compared to €4.890,1 mn in the corresponding period of 2018.

Total imports in January-December 2019 include the transfer of economic ownership of mobile transport equipment (vessels), with total value of €1.094,5 mn as compared to €1.875,1 mn in January-December 2018. Total exports in January-December 2019 include the transfer of economic ownership of mobile transport equipment (vessels), with total value of €995,2 mn as compared to €1.455,6 mn in January-December 2018.

Total imports

Imported goods were €691,6 mn in December 2019 and €858,4 mn in December 2018.

a. Total imports by H.S Section

For December 2019 Section XVII 'Vehicles, aircraft, vessels and associated transport equipment' lead the list with €199,0 mn, Section V 'Mineral products' with €90,6 mn followed by Section XVI 'Machinery and mechanical appliances, electrical equipment and parts' with €81,0 mn, Section IV 'Prepared foodstuffs, beverages, spirits and vinegar, tobacco and manufactured tobacco substitutes' with €63,9 mn, Section VI 'Products of the chemical or allied industries' with €59,1 mn, Section XV 'Base metal and articles of base metal' with €34,3 mn, Section II 'Vegetable products' with €22,7 mn and Section XI 'Textiles and textile articles' with €21,7 mn.

b. Total imports by economic destination

- Consumer goods valued at €193,4 mn or 28,0% in December 2019 and €175,1 mn or 20,4% in the respective month of 2018.
- Intermediate inputs valued at €179,9 mn or 26,0% in December 2019 as against €132,3 mn or 15,4% in December 2018. The manufacturing sector absorbed €120,6 mn in December 2019 as compared with €79,7 mn in December 2018. Raw materials for the construction sector were €29,0 mn in December 2019 and €23,2 mn in December 2018.
- Transport equipment with their parts accounted for €207,2 mn in December 2019 as compared with €395,6 mn in December 2018. Ships, boats and floating structures valued at €134,5 mn in December 2019 as compared with €333,4 mn in December 2018. Passenger motor vehicles were €51,8 mn in December 2019 and €42,9 mn in December 2018.
- Fuels and lubricants, including crude petroleum oil, valued at €61,9 mn in December 2019 and €96,3 mn in the corresponding month of 2018.
- Capital goods valued at €43,1 mn in December 2019 and €40,5 mn in December 2018. The manufacturing sector was €9,7 mn in December 2019 as against €7,7 mn in December 2018. Capital goods for the construction and mining sectors valued at €4,7 mn in December 2019 and €4,0 mn in December 2018. The transport, storage and communication sector valued at €6,9 mn in December 2019 and €6,5 mn in December 2018. Capital goods for agriculture accounted for €1,9 mn in December 2019 and €1,9 mn in the corresponding month of 2018.

c. Total imports by area

- The European Union continued to be the main source of supply of goods to Cyprus in December 2019, with a share of €420,7 mn of total imports. Major suppliers within the Union were Greece with €132,0 mn, Italy with €81,0 mn, Germany with €45,9 mn, the United Kingdom with €43,2 mn, the Netherlands with €26,3 mn, Spain with €18,7 mn, France with €15,5 mn and Belgium with €15,1 mn.
- Imports from all other European countries totaled €30,2 mn in December 2019 with Russia €16,4 mn, Ukraine with €3,9 mn and Switzerland with €3,3 mn.
- Imports from the rest of the world in December 2019 amounted to €240,7 mn with Bahamas €54,2 mn, China with €43,1 mn, Israel €22,7 mn, Bonaire, Sint Eustatius and Saba with €9,6 mn, Japan with €9,5 mn, Marshall Islands with €8,6 mn, the United States with €7,36 mn and India with €7,0 mn.

d. Total imports destined for home use

Imported goods destined for home use were €646,4 mn in December 2019 and €818,7 mn in December 2018.

Imports destined for home use by economic destination

- Consumer goods valued at €180,7 mn or 28,0% and €167,7 mn or 20,5% in December 2019 and December 2018, accordingly.
- Intermediate inputs valued at €177,3 mn or 27,4% in December 2019 as against €130,3 mn or 15,9% in December 2018. The manufacturing sector absorbed €119,1 mn in December 2019 and €78,9 mn in December 2018.
- Transport equipment with their parts accounted for €202,4 mn in December 2019 as compared with €392,0 mn in December 2018. Ships, boats and floating structures valued at €134,5 mn in December 2019 as compared with €333,4 mn in December 2018. Passenger motor vehicles were €47,8 mn in December 2019 and €41,2 mn in December 2018.
- Fuels and lubricants, including crude petroleum oil, valued at €38,1 mn in December 2019 and €70,9 mn in the corresponding month of 2018.
- Capital goods valued at €41,7 mn in December 2019 and €39,2 mn in December 2018. The manufacturing sector was €9,5 mn in December 2019 as against €7,7 mn in December 2018. Capital goods for the construction and mining sectors valued at €4,6 mn in December 2019 and €3,7 mn in December 2018. The transport, storage and communication sector absorbed €6,4 mn in December 2019 as against €6,1 mn in December 2018. Capital goods for agriculture accounted for €1,8 mn in December 2019 and €1,9 mn the respective month of 2018.

Total exports

Total exports, including stores and provisions, accounted for €253,7 mn in December 2019 as compared with €167,5 mn in December 2018.

a. Total exports, including stores and provisions, by H.S Section

For December 2019 Section XVII 'Vehicles, aircraft, vessels and associated transport equipment' lead the list with €103,4 mn, followed by Section VI 'Products of the chemical or allied industries' with €40,0 mn, Section V 'Mineral products' with €32,6 mn, Section I 'Live animals, animal products' with €19,6 mn, Section XVI 'Machinery electrical equipment and parts' with €17,0 mn, Section IV 'Prepared foodstuffs, beverages, spirits and vinegar, tobacco and manufactured tobacco substitutes' with €11,5 mn, Section II 'Vegetable products' with €5,3 mn and Section XV 'Base metals and articles of base metal' €7,1mn.

b. Total exports of domestically produced goods, excluding stores and provisions, by category

- Industrial products of domestic produce exported during December 2019 valued at €83,8 mn or 90,8% and €84,6 mn or 92,4% in December 2018.
- Exports of raw agricultural products valued at €6,9 mn or 7,4% in December 2019 and €5,1 mn or 5,6% in the corresponding month of 2018.
- Mineral exports valued at €0,4 mn or 0,5% in December 2019 and €0,5 mn or 0,5% in December 2018.

c. Total exports by area

- Exports to the European Union accounted for €102,5 mn in December 2019 of the total exports. Exports to Denmark accounted for €37,7 mn, to Greece for €16,9 mn, to the United Kingdom for €14,6 mn, to Germany for €4,6 mn, to Slovenia for €3,2 mn, to Romania for €3,0 mn, to Czech Republic for €2,8 mn and to France for €2,5 mn.
- Exports to Other European Countries accounted for €56,4 mn in December 2019, to Near and Middle Eastern countries for €19,1 mn, to North Africa for €15,9 mn, to Asian countries for €11,9 mn and to other countries of Oceania for €11,2 mn.
- Stores and provisions to ships and aircrafts in December 2019 valued at €21,0 mn, exports to countries and territories not specified in December 2019 valued at €1,6 mn and exports to high seas in December 2019 valued at €0,5 mn.

APPENDIX

DEFINITIONS OF TERMS USED

Arrivals

"Arrivals" are analogous to imports.

Arrivals include:

- a) goods in free circulation which enter the statistical territory of Cyprus;
- b) goods which have been placed under the CUSTOMS procedure for inward processing or processing under CUSTOMS control (for processing, transformation) in another Member State and which enter the statistical territory of Cyprus.
- c) Some goods movements are included in statistics based on specific conditions e.g. aircrafts and ships whose ownership has been transferred from a person established in another Member State to a person established in the Cyprus are included in the statistics of arrivals of Cyprus.

Dispatches

"Dispatches" are analogous to exports.

Dispatches include:

- a) goods in free circulation which leave the statistical territory of Cyprus bound for another Member State;
- b) goods which have been placed under the CUSTOMS procedure for inward processing or processing under CUSTOMS control (for processing, transformation) in Cyprus and which are destined for another Member State.
- c) Some goods movements are included in statistics based on specific conditions. In particular, aircraft and ships whose ownership has been transferred from a person established in the Cyprus to a person established in another Member State are included in the statistics on dispatches of Cyprus.

Imports

Imports **under special trade system** include:

- a) Goods, which enter the statistical territory of Cyprus from a non-member country and are:
 - Placed under the CUSTOMS procedure for release into free circulation (goods intended to be consumed in Cyprus or dispatched to another Member State), either immediately or after a period in a CUSTOMS warehouse or
 - Placed under the CUSTOMS procedure for inward processing or processing under CUSTOMS control (usually goods destined to be processed, transformed for subsequent re-export) either immediately or after a period in a CUSTOMS warehouse.
- b) Some movements of goods are included in statistics based on specific conditions e.g. aircrafts and ships whose ownership has been transferred from a person established in a non-member country to a person established in Cyprus are included in import statistics of Cyprus.

Exports

Exports **under special trade system** include:

- a) goods that leave the statistical territory of Cyprus bound for a non-member country, having gone through:
 - The CUSTOMS export procedure (final export, export following inward processing, etc.); or
 - The CUSTOMS outward-processing procedure (usually goods destined to be processed, transformed for subsequent re-import).

The Harmonized Commodity Description and Coding System (HS) Partner country

The Harmonised System is a legal instrument adopted by the Customs Co-operation Council (now the World Customs Organisation) in June 1983 and the International Convention on the Harmonised System (H.S. Convention) entered into force on the 1st January 1988.

According to the H.S. Convention, the HS "means the Nomenclature comprising the headings and the subheadings and their related numerical codes, the Section, Chapter and Subheadings notes and the General Rules for the interpretation of the Harmonised System". The H.S. is designed as a "multipurpose nomenclature", to be used for transportable goods. Both H.S. and C.N. are therefore concerned heavily with the nature or material of the product.

For exports and dispatches, the trading partner is the country (or Member State) of final destination of the goods. The last country to which the goods are specifically directed on their outward movement from the State is regarded as their final destination. This is not necessarily the country in which the good will be unshipped or that in which they will be finally consumed.

For imports (extra-EU trade), the trading partner is the country of origin. In general, goods obtained entirely from a given country originate in that country. A product, in the production of which two or more countries were concerned, is considered as originating in the country in which the last transformation or substantial processing took place. Packing repacking, sorting and blending are not regarded as manufacturing processes.

The shape of the H.S. and the C.N. classifications is illustrated in the following table:

For arrivals (intra-EU trade), the trading partner is the Member State of consignment of the goods.

Trade systems

There are broadly two approaches, closely linked with customs procedures, used for the measurement of international trade in goods: the general trade system and the special trade system.

General trade system

The general trade system is the wider concept and under it the recorded aggregates include all goods entering or leaving the economic territory of Cyprus with the exception of simple transit trade. In particular all goods which are received into customs warehouses are recorded as imports at that stage whether or not they subsequently go into free circulation in Cyprus. Similarly, outgoing goods from customs warehouses are included in the general trade aggregates at the time they leave Cyprus.

Country classification

The classification of countries is the country nomenclature (Geonomenclature) as set annually in the Official Journal of the European Communities. The full list of countries is given in an essentially geographical order in Table 4, Part A, Total trade statistics.

Special trade system

The special trade system is a narrower concept. Goods from a foreign country which are received into customs warehouse are not recorded in the special trade aggregates unless they subsequently go into free circulation in Cyprus (or are placed under the customs procedures for inward processing). Similarly, outgoing goods from customs warehouses are not recorded as exports.

Stores and provisions

Stores and provisions denote ships' and aircraft's stores and supplies.

- ships and aircraft's stores' means the various products for consumption by the crew and passengers of vessels or aircraft;

- ships and aircraft's supplies' means the products for the operation of the engines, machines and other equipment on vessels or aircraft, such as fuel, oil and lubricants.

Domestic and foreign goods

Domestic goods are goods originating in the economic territory of Cyprus; if they have been wholly obtained in it or were substantially transformed by processing in it, so that the processing confers domestic origin. Goods originally imported and having undergone only repair or minor operations which leave them essentially unchanged are not defined as domestic. Minor operations include blending, packaging, bottling, cleaning, sorting, husking and selling.

Foreign goods are goods originating in the rest of the world, i.e not included in the economic territory of Cyprus and compensating goods obtained under the outward processing procedure when such processing confers foreign origin.
