3.1. Data description

Data and metadata are transmitted to Eurostat by the Member States in the framework of the Unified Demographic Data Collection which is in accordance with <u>Regulation (EC) No 862/2007</u> and <u>Regulation (EU) No 1260/2013</u> and their implementing regulations.

6. Institutional Mandate

6.1. Institutional Mandate - legal acts and other agreements

Article 3 of the national Statistics Law, No. 15(I) of 2000 defines the functions of the Statistical Service of Cyprus regarding the production and dissemination of official statistics. Moreover, Article 11(1) explicitly stipulates the mandate for data collection and introduces a mandatory response to statistical enquiries by stipulating the obligation of respondents to reply to surveys and provide the data required. This relates not only to national but also to European statistics, which, by virtue of Article 15 of the said Law, are incorporated in the annual and 5-year programmes of work without any further procedure.

Micro-data may then be released after an anonymisation process, which ensures no direct identification of the statistical units but, at the same time, ensures usability of the data. 15.3. Coherence - cross domain

Concerning migration statistics, some differences may exist between figures published by CYSTAT and figures available from administrative sources, due to different definitions and methodologies used. At the moment, plans are being made by the Statistical Service to make greater use of administrative sources (one of them being the Residence Permits database), and to try to link the two domains. It is expected that in the coming years there will be greater coherence between the two sources and disparities will be eliminated.

Turkish Cypriots residing in the occupied area of Cyprus are not included in the figures on births, deaths, immigrants, emigrants and population sent to Eurostat.

18.6. Adjustment

The balancing equation: Population of previous year plus natural change (live births minus deaths) plus net migration (immigrants minus emigrants) equals the population on 1 January of the reference year (the demographic balance for total population).
