

# FISCAL ACCOUNTS OF GENERAL GOVERNMENT: JAN-SEP 2025

# Surplus €1.169,5 mn

The preliminary General Government fiscal results, which are prepared by the Statistical Service of Cyprus (CYSTAT) indicate a surplus of €1.169,5 mn (3,2% of GDP) for the period of January-September 2025, as compared to a surplus of €1.344,3 mn (3,9% of GDP) that was recorded during the period of January-September 2024.



#### **Revenue**

During the period of January-September 2025, total revenue increased by €650,1 mn (+6,2%) and amounted to €11.197,5 mn, compared to €10.547,3 mn in the corresponding period of 2024.

In detail, revenue from taxes on income and wealth increased by €182,2 mn (+6,7%) and amounted to €2.892,9 mn, compared to €2.710,7 mn in 2024. Social contributions increased by €237,0 mn (+7,3%) and amounted to €3.474,0 mn, compared to €3.237,0 mn in 2024. Property income increased by €56,2 mn (+77,6%) and amounted to €128,6 mn, compared to €72,4 mn in 2024. Taxes on production and imports increased by €24,1 mn (+0,7%) and amounted to €3.535,2 mn, compared to €3.511,1 mn in 2024, of which net VAT revenue increased by €11,6 mn (+0,5%) and amounted to €2.375,2 mn, compared to €2.363,6 mn in 2024. Revenue from the sale of goods and services increased by €115,9 mn (+17,9%) and amounted to €765,0 mn, compared to €649,1 mn in 2024. Capital transfers increased by €45,8 mn (+65,0%) and amounted to €116,3 mn, compared to €70,5 mn in 2024.

On the contrary, current transfers decreased by  $\leq 11,1$  mn (-3,7%) to  $\leq 285,5$  mn, from  $\leq 296,6$  mn in 2024.

#### **Expenditure**

During the period of January-September 2025, total expenditure increased by €824,9 mn (+9,0%) and amounted to €10.028,0 mn, compared to €9.203,1 mn in the corresponding period of 2024.

In detail, compensation of employees (including imputed social contributions and pensions of civil servants) increased by €175,9 mn (+6,5%) and amounted to €2.870,2 mn, compared to €2.694,3 mn in 2024. Social benefits increased by €274,1 mn (+7,2%) and amounted to €4.082,2 mn, compared to €3.808,1 mn in 2024. Intermediate consumption increased by €74,3 mn (+7,6%) and amounted to €1.046,4 mn, compared to €972,1 mn in 2024.

The capital account increased by €371,3 mn (+55,9%) and amounted to €1.036,0 mn, compared to €664,7 mn in 2024, of which gross capital formation increased by €164,2 mn (+29,0%) and amounted to €731,3 mn, compared to €567,1 mn in 2024 and other capital expenditure increased by €207,1 mn and amounted to €304,7 mn, compared to €97,6 mn in 2024.

On the contrary, interest payable decreased by €3,7 mn (-1,1%) to €326,3 mn, from €330,0 mn in 2024. Current transfers decreased by €49,8 mn (-8,2%) to €558,8 mn, from €608,6 mn in 2024. Subsidies decreased by €17,2 mn (-13,7%) to €108,1 mn, from €125,3 mn in 2024.

## **Important Notice**

It is emphasized that for a number of entities of the General Government and specifically for the Local Government Subsector, estimates have been produced by the Statistical Service, due to non-submission of sufficient data by the competent authorities.

# **METHODOLOGICAL INFORMATION**

## **Data Coverage and Methodology**

Information is provided for the whole sequence of accounts for the General Government sector. The revenue and expenditure are analyzed by category and these are classified between current and capital, respectively.

The categories of revenue and expenditure for General Government cover all the subsectors of the General Government based on the European System of Accounts 2010 (ESA 2010).

## **Source of Data**

The data is collected from:

- Financial Information Management Automation System (FIMAS) for Central Government, Extra Budgetary Funds and Social Security Funds,
- Budget execution of Municipalities and Communities,
- Budget execution of Semi-Government Organizations.

For the completion of the estimates, any methodological adjustments or corrections based on the European System of Accounts 2010 (ESA 2010) are taken into account.
